1. Introduction

The creation of humankind is one of the greatest signs of Allah Almighty, which is why *Shari'ah* counts human life very precious and has commanded for its protection and safety in the Holy *Qur'ān* and the *Sunnah* of the Prophet (Peace be upon him).

Qur'ān says in this regard:

"Do not kill a person, whom Allah has given sanctity, except rightfully" (Al- An'ām: 151).

"Do not kill your children for fear of poverty. We provide sustenance to them and to you, too. Killing them is a great sin indeed. (Al-Isrāh: 31).

"Whoever kills a believer deliberately, his reward is Jahannam (Hell) where he shall remain forever, and Allah shall be angry with him and shall cast a curse upon him, and He has prepared for him a mighty punishment".(Al-Nisā: 93).

Allah has granted life to a person as trust and will question him about it on the day of the judgment. Thus, a person cannot harm himself considering his body as his property nor can he inflict any aggression on the person of another. This is the reason that suicide and mutilation of a human body or any of its organs are prohibited in Islam, except under *Maslaḥah*. Even passive aggression towards oneself is considered against the injunctions of *Shari'ah*, which includes avoiding required medication, ignoring personal hygiene, sticking to evil habits, instigating fights among the masses, and taking intoxicants.

Shari'ah has not confined itself to mere preaching of these highly valued ethics; rather, it has prescribed penalties in certain cases for their infringers, especially where such values are prescribed by way of commands. *Qur'ān* says:

"There is life for you in Qisās (retaliation), O people of wisdom, so that you may refrain (from killing)" (Al-Baqarah: 179).

To highlight the importance of human life and the ways of its protection under *Shari'ah* and contemporary laws, and for the dissemination of such research, Faculty of Shari'ah & Law, International Islamic University Islamabad, in collaboration with the Higher Education Commission of Pakistan and International Islamic Fiqh Academy Jeddah, is going to organize the 4th International Conference on the Protection of Human Life in *Shari'ah* and Law.

2. OBJECTIVES OF THE CONFERENCE

- (a) Exhibition of the true concept of right to life and its protection along with its application in *Shari'ah*.
- (b) Presentation of various issues pertaining to the protection of human life and practical solutions to it in light of *Shari'ah* and contemporary laws.

(c) Promotion of an individual and collective culture for the protection of human life by creating awareness among the masses and other stakeholders.

3. THEMES OF THE CONFERENCE

The research paper should be in one of the following themes of the Conference.

4. GUIDELINES FOR THE SUBMISSION OF RESEARCH PAPERS

- (i) The research paper should adopt proper methodology.
- (ii) The language of the research paper should be well considered.
- (iii) The research should be original and should not have been published or presented elsewhere in any manner prior to this Conference.
- (iv) The foreign terms must be italicised.
- (v) The research paper should be between 4000 to 10000 words including the footnotes, tables and figures.
- (vi) The research paper should clearly indicate the heading levels.
- (vii) The references should be numbered consecutively in the footnotes whose accuracy is the responsibility of the contributor. All citations should follow the Chicago Manual of Style (16th Edn.).
- (viii) The contributors may include tables and figures in their submissions with a condition that the tables are straightforward and comprehensible and the figures are submitted as separate files.
- (ix) The researcher shall provide the following:
 - (a) Abstract (softcopy) of not more than 300 words

- (b) Title page with the following details:
 - Title of the research paper
 - Name and email address of the researcher
 - Current affiliation and designation of the contributor
- (c) Brief CV (curriculum vitae) of not more than one page
- (d) Softcopy of the paper if the abstract is approved
- (e) Copy of passport, in case of foreign contributor

5. GENERAL RULES AND SPECIFICATIONS

- 5.1 The submissions are subject to the rigorous review and evaluation by the Academic Committee of the Conference for the approval.
- 5.2 The Academic Committee may require a contributor to make amendments to the submission before its final approval.
- 5.3 The Academic Committee may reject the submissions without any obligation to provide justification for non-approval.
- 5.4 The selected papers will be approved for presenting in the Conference.
