**DEED OF AGREEMENT**

The approved student has agreed to accept the award of the Qardh-e- Hasanah on the terms and conditions governing the Qardh-e- Hasanah Scheme.

Now this deed witnesses as under:

- i) The payment of dues admissible under the Qardh-e- Hasanah program shall be made subject to the complete adherence to all rules and regulations governing the Qardh-e- Hasanah program as well as satisfactory performance in the authorized studies.
- i) The student shall not change the specified course of studies nor register himself/herself for any other course or program/University/Institute without prior approval of the IIU Alumni Committee.
- ii) The student shall not extend the specified period of studies without prior approval of the IIU Alumni Committee. **In case of selection in any other scholarship scheme the student will immediately report the same at the university.**
- iii) The Parents/ Guardian of the student are unable to financially support his/her education.
- iv) The Qardh-e- Hasanah will be terminable in the following cases:
  - a) If the student fails to maintain class attendance of 75%.
  - b) If the student is involved in malicious/undesirable activities.
  - c) If the student fails to obey or act in accordance with University’s order directing him/her, he/she will be liable to action under the acts/rules in force in the country.
  - d) If the student is punished because of his involvement in violation of the university rules, damage to institute property, misbehavior with staff or colleagues or any other disciplinary action.
  - e) **If the information provided by the student is found incorrect at any time during his study period.**
  - f) If the student fails to maintain academic standards of the university
- v) The International Islamic University, Islamabad undertakes the financial liability of the payment of Qardh-e- Hasanah Scheme subject to the completion of all codal formalities and approval of competent authority and availability of funds.
- vi) Once the final approval is accorded, a deed of agreement shall be signed between the student and the UAFA with the guarantee of his/her parents/guardian/spouse.
- vii) The repayment schedule will be structured so as to allow full repayment once the student is graduated, employed and financially stable. The maximum duration of full loan repayment must not exceed 10 years after graduation of Undergraduate students.
- viii) It will also be the moral responsibility of every recipient to payback the received Qardh-e- Hasanah Scheme amount within the stipulated time period so that maximum deserving students can continue to benefit from this initiative.

AND THE STUDENT FURTHER COVENANTS, that in case of breach of any of the above terms and conditions as well as the rules / terms and conditions those governing Qardh-e- Hasanah award and / or his / her failure as directed by the SAFE Committee for the specified period, the student shall be bound to obey the orders as prescribed and assessed by the SAFE Committee shall be final and conclusive.
